About Central Indiana Community Foundation (CICF)

Central Indiana Community Foundation (CICF) was formed in 1997 through a partnership with The Indianapolis Foundation, serving Marion County since 1916, and Legacy Fund, serving Hamilton County since 1991. CICF's mission is to inspire, support, and practice philanthropy, leadership, and service in our community.

With more than \$675 million in assets, CICF ranks within the top 25 largest community foundations in the United States. This success has been accomplished, in large part, thanks to donations from individuals and businesses who are interested in enhancing the quality of life in central Indiana. CICF is committed to working with individuals and families who want to give back to their community.

Our Scholarship Program

CICF and its donors are committed to helping students pursue and complete higher education degrees. In 2007, CICF awarded over \$1.5 million to 134 new scholarship recipients from scholarship funds established by individuals, families, and businesses. Unfortunately, CICF is forced to turn down deserving students each year simply because there is not enough money available to meet the need.

How to Apply

You will find in this booklet three lists of scholarship funds. While CICF manages the money for all of these funds, the application processes are different for each list.

Section A: Pages 4-7 contain scholarship opportunities for which you send scholarship application material to CICF. The common scholarship application is on Page 17.

Section B: Pages 8-12 contain scholarships for which the Foundation also holds funds administered by local schools, education foundations and/or other organizations. Please contact the appropriate organization and/or your guidance counselor for information on additional scholarship opportunities:

Frequently Asked Questions

Am I eligible to apply? Please read through the specific criteria for each scholarship fund listed on pages 4-12 to see if you are eligible to apply.

What if I have questions? If you have any questions, please call the CICF Scholarship Student Information Line at 317.631.6542, ext. 279 or email scholarships@cicf.org.

If I am awarded a scholarship, how can it be used? Scholarships are for educational expenses at a college or university: tuition, required fees, room, and board. Scholarships at CICF will only pay for a part of these expenses.

If I am awarded a scholarship, how much will I get? Most scholarship funds offer varying award amounts, which range from \$1,000 to several thousand dollars. Awards depend on the size of the particular fund and the number of qualified applicants. Award amounts may vary from year to year.

Where can I go to school? Most of the scholarships are for students attending schools anywhere in the United States unless otherwise noted in the scholarship description. Some scholarships are designated for students attending an Indiana institution.

May I receive awards from more than one scholarship fund? Yes. You may apply to all the funds for which you are eligible and it is possible to receive multiple awards.

What is the timeline for scholarship decisions and notification?

Deadlines vary and are stated under the scholarship description. **All materials must be received on or before the stated deadline. Late or incomplete applications are not considered.**

CICF's scholarship selection committees meet and select recipients from April to June. All applicants are notified about committees' decisions by Scholarship America.

What happens after I receive my scholarship?

For a majority of scholarships, you will be notified by Scholarship America, an organization that assists CICF with the administration of its scholarships including award notification, scholarship payment, enrollment verification and student reporting.

When and how will my scholarship be paid?

Recipients must submit scholarship acceptance agreements before a scholarship will be paid. For a majority of scholarships, scholarship checks are sent in August provided students have submitted required paperwork. Checks are made payable to the college or university and sent directly to scholarship recipients.

Will I be asked to submit any year-end reports for my scholarship?

For a majority of scholarships, students are asked to submit reports verifying enrollment, grades, major, and contact information. In some cases an essay or additional information may be required.

About CICF's Scholarship Fund Donors

Ambassador Randall L. Tobias and Dr. Marianne W. Tobias Endowed Scholarship Fund – This Fund was created to promote and encourage students of Mexican descent to pursue higher education. Tobias Scholars are required to submit semi-annual letters written in Spanish about their academic progress.

Benjamin Drayer Memorial Endowed Scholarship Fund – This scholarship was established in memory of Ben Drayer by his paternal grandparents, Roger and Janet Drayer. Ben was an enthusiastic young man with a positive attitude and an enthusiasm for school who lost his battle with cystic fibrosis in 1997.
